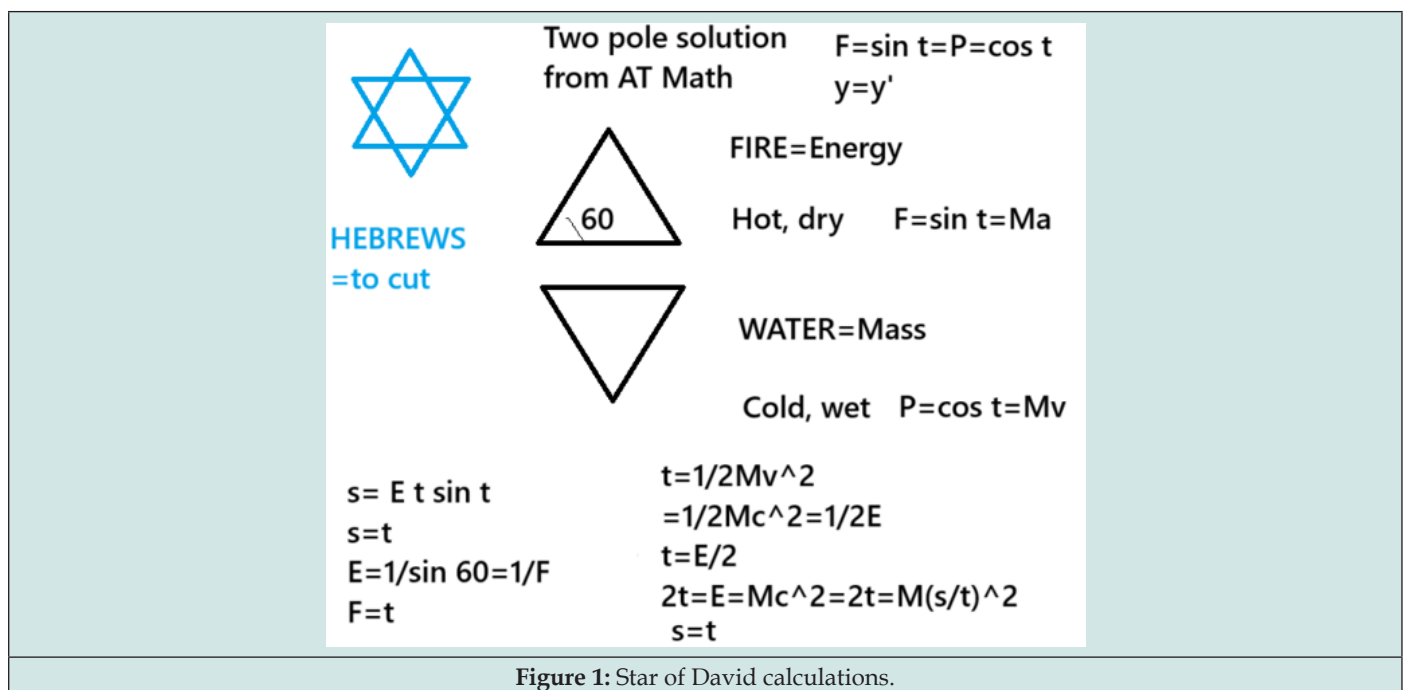


Figure 1: Star of David calculations.

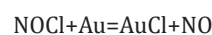

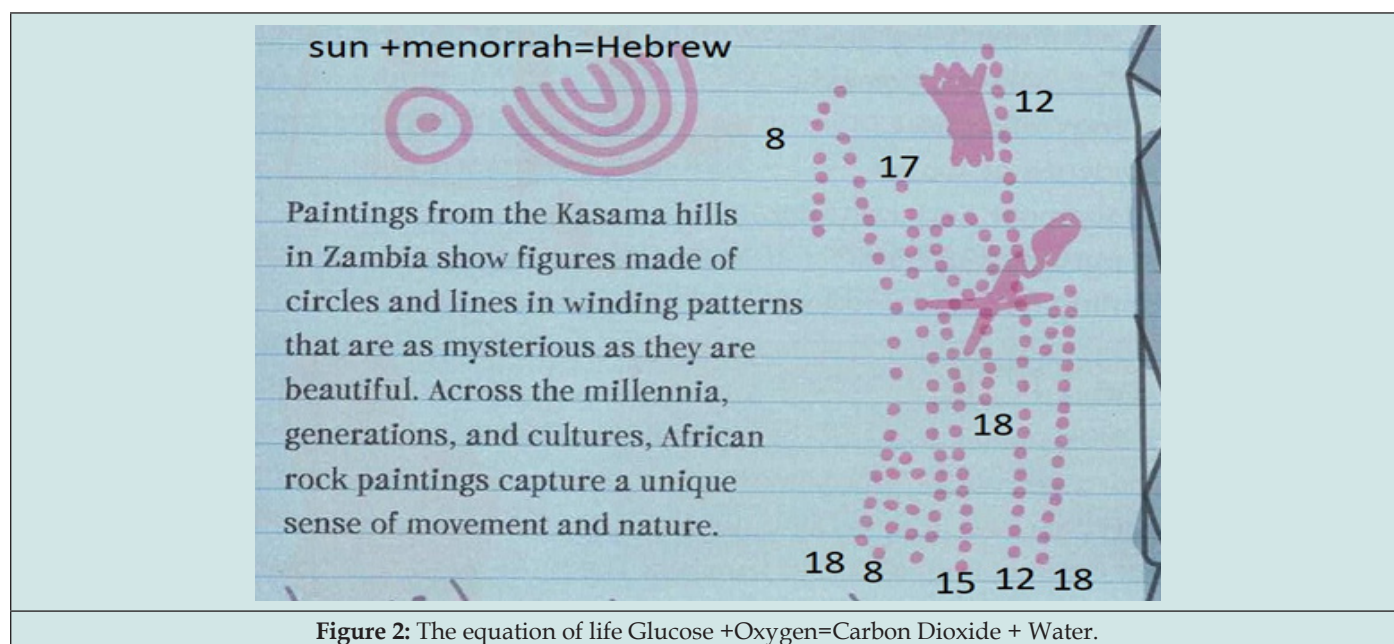

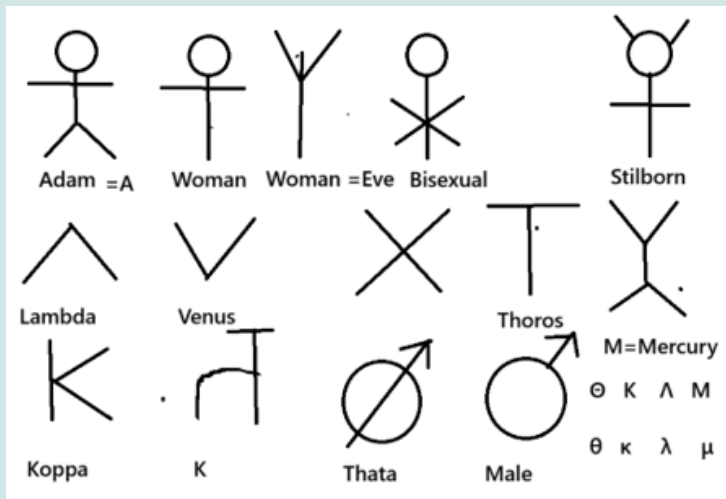


Figure 3: Male and female and Planet symbols used in Alchemy and Astrology.

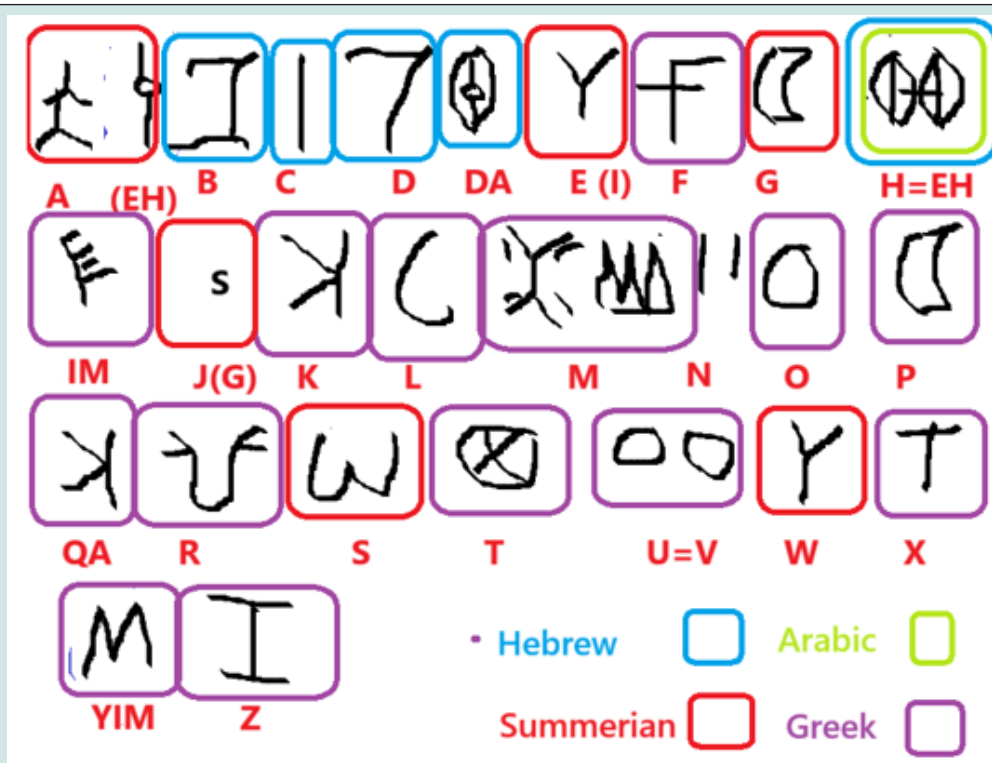


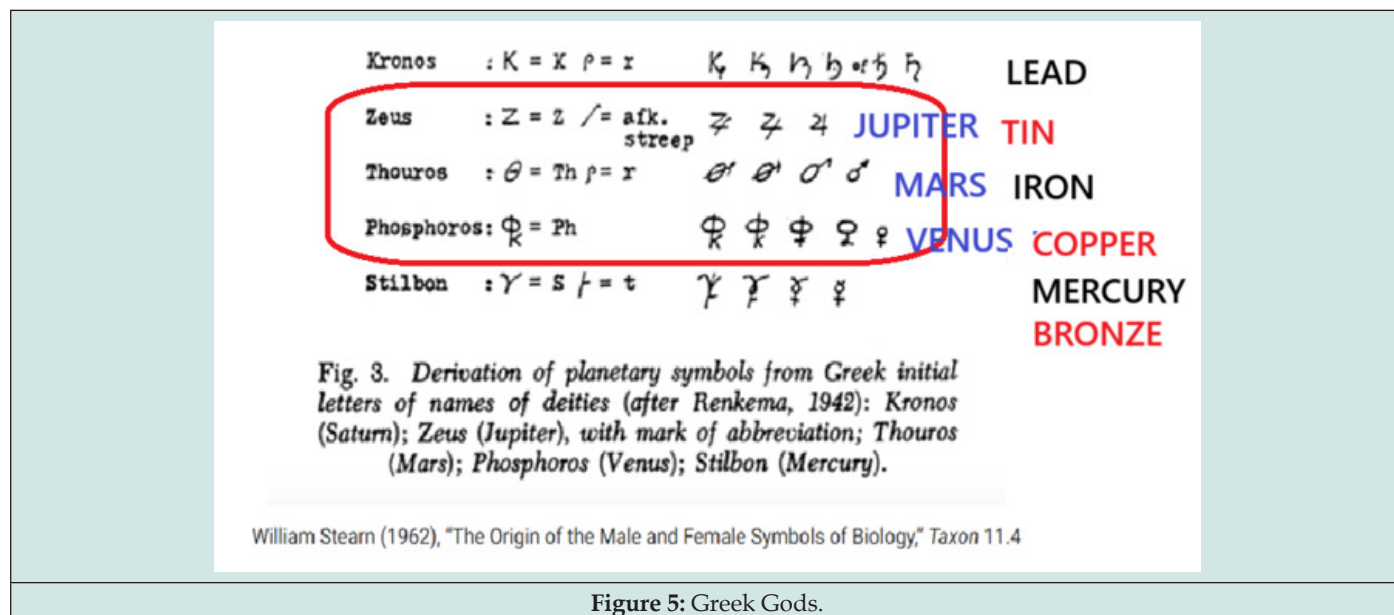
Figure 4: the Harappan script to Latin.

In Revelation 2:28, the “morning star” symbolizes Jesus Christ and represents the promise of His presence and authority to those who overcome.

Context of Revelation 2:28

In this verse, Jesus addresses the church in Thyatira, promising to give the “morning star” to those who remain faithful and overcome challenges. This promise is part of a series of messages to the seven churches, encouraging believers to persevere in their faith despite trials and temptations.

The “morning star” is a symbol with rich biblical significance. In ancient times, the morning star, often identified with the planet Venus, was seen as a herald of a new day, symbolizing hope and renewal. Biblically, the morning star is associated with Jesus Christ Himself, as seen in [Revelation 22:16](#), where Jesus declares, “I am the Root and the Offspring of David, and the bright Morning Star.” This

connection suggests that the promise of the morning star is a promise of Christ Himself, His presence, and His kingdom. The morning star also signifies victory and authority, as it was a symbol of kingship and divine favor. In the context of Revelation, it represents the ultimate triumph of Christ and His followers over evil, pointing to the eschatological hope of eternal life and reign with Christ.

The story of Adam and Eve and the Garden of Eden go back at least as far as the Sumerian language. Indeed, the letter “A” and “E” represent Adam and Eve. The Garden of Eden was in the Indus Valley – lush vegetation and lots of rivers. The four rivers are the Nile, the Euphrates and Tigris and the Indus River. Located in the Garden of Eden is the Tree of Knowledge and the Tree of Life. Adam and Eve were forbidden by God to eat of the tree of knowledge or they would die. The secret knowledge is Astrotheology and consciousness which this author has written extensively about. It is also about physics and chemistry.
