I propose a new, safe, novel, and instantaneous method of abortion viz-the handheld electric zapper/catheter. At present there are two methods of abortion in existence-the surgical and the medical. The electric zapper could be applied externally while the electric catheter could be applied internally via the vagina. The mother could be locally anaesthetized or wide awake. 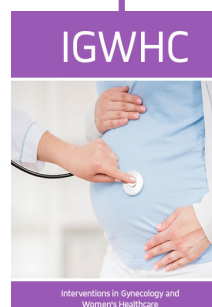
